- President Bob Hutchinson informed the entire board that at our last meeting 6-6-15 a "Breach of Rules" occurred. Please see the minutes
   New Business 2nd Bullet Point Rod Connelly made a motion to explore the idea of having a 2016 combined NTA/PTA convention on June
   6-12, 2016 2nd by John Czerniakowski motion carried with a count of 9 for and 1 opposed. ONLY Board Members can make & 2nd
   motions at a Board of Directors Meeting. John Czerniakowski is no longer a Board Member just a General Member and should not of 2nd
   this motion. However, this POINT-OF-ORDER was not recognized at the time of the breach and a vote was taken and we have to follow
   through with it.
- The board discussed discharging a committee Per Roberts Rules by means of a motion to Discharge a Committee from further consideration of a question or subject, the assembly can take the matter out of a committee's hands after referring it to the committee and before the committee has acted on or made a final report on it, and the assembly itself can consider it. So long as a question is in the hands of a committee, the assembly cannot consider another motion involving practically the same question. In the best interest of our show and association, we should discuss discharging the committee that was appointed of Becky Snyder, John Czerniakowski, & Tim Jordan of going to 7 Springs. Jason Krause made a motion to discharge the committee, (Becky Snyder, John Czerniakowski, and Tim Jordan), that was formed to go to 7 springs 2nd by Bill Ward motion carried with a vote of 8 for, 2 absent, and 1 abstain.
- The Board discussed the 7 Springs Contracts and directing Becky Snyder, as Convention Coordinator, to inquire about the "Cancellation Clause" of our contracts explaining that we are exploring the idea of having a combined 2016 event with the NTA and report back to the board ASAP so that she in turn can report those findings to the NTA in time for their monthly conference call on the 25th of June. This is the only thing that was asked of us from the NTA at our last board meeting. Joe Simmons made a motion to have Becky Snyder contact 7 springs regarding our contract to see if it's even possible to move our date, she can do it via email or phone call 2nd by Jessica Simmons motion carried with a vote of 5 for, 4 opposed, 1 absent, and 1 abstain. Becky Snyder reported that if we decide to move into June 2016 & combine our event with the NTA's there would not be any penalty to the PTA. Our deposit would roll into another year. 7 Springs does have concern that they may run out of sleeping rooms as there are other in-house events going on (I don't know what the NTA has held) if we choose to combine our events Sherry will check into the possibility of overflow rooms at Hidden Valley at that time.
